Ideal for applications where both security and accessibility are a priority.





### Pull Side, Door Mounted

- 140° swing (trim permitting)
- Hold open model, specify 422 x CTHB2



### Push Side, Frame Mounted

- Maximum frame reveal is 4" (102mm)
- An auxiliary door stop is required
- 110° swing (trim permitting) without spring stop
- If hold open required, consult factory








### Push Side, Door Mounted

- Minimum frame reveal is 1-1/2" (13mm)
- 110° swing (trim permitting)
- 63-0853-EN slide track angle bracket required (sold separately)
- Hold open model, specify 422 CTHB2



### Pull Side, Frame Mounted


- 140° swing (trim permitting)
- 422D back plate required if frame face is less than 3" (sold separately)
- Hold open model, specify 422 CTHB2

# Function

## 422 Cam Action



**Inclusive Restroom Function:** A standard 422 closer can be configured for an inclusive restroom application, commonly known as the telephone booth, with a minor adjustment during the installation process. See the installation instructions for specific details. When configured, the closer functions as follows:

- Closer normally holds door open at approximately ten (10) degrees; standard spline arm allows degree of hold open to be adjusted up or down
- Upon entering room, a user can push or pull the door closed
- When a user exits the room, the closer allows the door to open normally and returns the door to the preset position
- The standard cushion stop block and optional hold open assembly can be installed in the track to provide additional door control

**422D Drop/Back Plate:** For use where the narrow top rail of the door prevents the closer from being mounted directly to the door surface. This drop plate must be used for closer mounted on a top rail between 1-7/8" and 3-3/8" (48 and 86mm) in height.

Door Closers, Surface Mounted (Cam Action):

- ANSI/ BHMA 156.4, Grade 1 Certified Products Directory (CPD) listed surface mounted, high efficiency door closers with complete spring power adjustment, sizes 1 thru 6; and fully operational adjustable according to door size, frequency of use, and opening force.
- Closers to be of the cam and roller design, one piece cast aluminum silicon alloy body with adjustable backcheck and independently controlled valves for closing sweep and latch speed.
- Door closer to have adjustable hold open position with an on/off selector.
- Non-hold open units to be U.L. Listed for self-closing door.
- Unit to be in compliance with the requirements of the Americans With Disabilities Act (ADA). ANSI standards A117.1.
- Units to meet C-UL US.
- Closers to carry a 30-year warranty

### General Information

---

**NOTE:**

- Door closer warranty becomes void if the closer is installed on the exterior side of a door in the exterior wall of a building.
- It is strongly recommended, and may be required on fire door assemblies, that doors having a door closer be hung on ball-bearing or anti-friction hinges or pivots. Consult local authority having jurisdiction.
- Failure to use fasteners supplied with closer may void factory warranty.
- Fasteners for fire/smoke door assemblies must conform to NFPA 80. In some applications additional fasteners may be mandated by NFPA 80 that are not shipped with standard SARGENT product, such as sleeve-nuts/sex-nuts or thru bolts and grommet nuts.
- Information provided is based on 1-3/4" (44mm) x 7' (2.13m) standard weight doors swinging to 110°. Other conditions (such as door height or weight; or wind/draft conditions) may require adjustment of spring setting, selection of a larger size closer or different closer.


